

## Widefield School District 3 School of Choice Permit Application



In accordance with Board of Education Policy JFBA/JFBB, general guidelines have been established for parents/guardians who want their students to attend a school other than the school in their attendance area. Parents/Guardians requesting a permit must complete and submit this form, along with the following documents, to the school you wish your student to attend.

- ✓ If your student's current school is **within** the District 3 attendance area, please attach a copy of your child's most recent transcript or report card, attendance report and discipline report.
- ✓ If your student's current school is **outside** the District 3 attendance area, please attach copies of your child's latest transcript or report card, birth certificate and immunization record, attendance report and discipline report.

An approved application for a permit will be valid for only one (1) school year. **A new permit application must be completed each year during the application window.** For in district and current students, applications are due no later than the last school day in February. For new out of district students, applications are due no later than the first Friday in May for the following school year. For any application received after the deadline, students will be placed on a waiting list. Transportation will be the responsibility of the parent. If this permit is approved, the parent/guardian and student will have to follow the normal registration process.

- The student has exhibited chronic behavior or attendance concerns during the current year.
